6 **WHEREAS**, Black history is American history, and for over a century, Black Americans have
7 led the fight for equity, justice, and opportunity, reshaping our culture, laws, and
8 democracy in ways that continue to resonate today; and

10 **WHEREAS**, the Port of Seattle is committed to racial equity and confronting anti-Black racism
11 by embedding inclusion, belonging, and fairness across its operations and
12 leadership, reflecting our diverse communities, creating an equitable culture, and
13 ensuring that opportunities expand economic and social well-being for all; and

15 **WHEREAS**, 2026 marks a century of national Black history commemorations, honoring the
16 vision and leadership of Dr. Carter G. Woodson and the founders of the Association
17 for the Study of Negro Life and History, whose work institutionalized the study,
18 celebration, and preservation of Black history and affirmed the countless
19 contributions of Black Americans to the cultural, economic, political, and social
20 foundations of this nation; and

22 **WHEREAS**, from that vision and leadership, the roots of Black History Week grew to Black
23 History Month, and these observances have transformed how Black Americans
24 view themselves, how the world recognizes their contributions, and emphasizes the
25 enduring power of remembrance, education, and celebration; and

27 **WHEREAS**, the Port of Seattle honors the historic and ongoing contributions of Black leaders,
28 Black employees, and all Black Americans to the economic, cultural, and social life
29 of King County and beyond, including through leadership at the Port, participation
30 in Employee Resource Groups, engagement with the Change Team, involvement
31 with Blacks In Government, and the everyday actions of our Port family advancing

34 **WHEREAS**, Blacks In Government is part of a national non-profit organization that celebrated
35 its 50th anniversary last year. We are an inclusive organization and invite everyone
36 to share our purpose, and join in our mission, as we work toward achieving our

WHEREAS, Blacks In Government's purpose is to advance equity and empowerment for Black public servants by fostering a community where learning and leadership strengthen both individual potential and collective progress. Our mission is to create avenues for educational opportunities, career advancement, and to provide a mechanism for inclusion, growth, and advocacy. Our vision is a mosaic that embodies the belief that all people, regardless of race, color, gender, gender identity, religion, or citizenship status, can embrace who they are, define their future, and change the world; and

WHEREAS, at a time when the current federal administration is actively attempting to erase Black history, restrict truthful education, and dismantle hard-won civil rights gains, the Port of Seattle unequivocally acknowledges that Black Americans—many of whom were forced to build this nation through enslavement, exploitation, and systemic dehumanization—have shaped every aspect of the United States, and we reject any effort to deny, distort, or diminish that reality; and

WHEREAS, the Port of Seattle Commission continues to elevate and honor the contributions of Black Americans through sustained institutional commitment, inclusive policies, education, and recognition, ensuring that Black history is preserved, celebrated, and carried forward as an essential and living part of our shared civic and cultural story.

NOW, THEREFORE, the Port of Seattle Commission proclaims February 2026 as Black History Month, honoring the legacy of those who paved the way, those advancing equity today, and all members of the Port family committed to justice, inclusion, and Black excellence.

TRANSPARENCY:

In approving the delegations for the Executive Director, the Commission requested that staff ensure transparency as it is paramount moving forward. As a result, staff will make approvals visible to the public in two ways. First, these types of approvals will be made visible in public Commission meetings via monthly reporting similar to this one. This approval is both timed and designed to be visible in a similar manner to the monthly Claims and Obligations reporting. Second, staff will publish these delegations to the web by publishing them in a PeopleSoft formatted report on the Port website in the same manner that all procurements, contracts, and other opportunities are made available to public communities.

BACKGROUND:

On January 24, 2023, the Commission approved and adopted Resolution No. 3810 that repealed related prior resolutions and increased the previously delegated Commission authority to the Executive Director and provided clarity in process directives to port staff. The approval made the Delegation of Responsibility and Authority to the Executive Director (DORA) effective on April 3, 2023, and the approvals made by the Executive Director for the month of April are identified in the table above.

The foundation for Resolution No. 3810 included significant data analysis, employee surveys, and internal audit recommendation. Resolution No. 3810 also aligns with the Port Century Agenda in that it helps make the Port a more effective public agency. Many considerations and checks and balances have been built into the associated processes of Executive Director approvals including a high bar of transparency.

Following significant analysis and multiple Commission reviews, the Commission approved the DORA on January 24, 2023. That reporting memo is available for review on the Port website under the January 24, 2023, Commission public meeting, and it provides detailed reasoning and explanation of Resolution No. 3810.

ACTION REQUESTED

Request Commission to adopt the 2026 International Policy Agenda.

EXECUTIVE SUMMARY

Port of Seattle Commissioners, executive team members, and internal subject-matter experts are engaging internationally to build relationships, share the opportunities and challenges of operating maritime and aviation gateways, and advocate in support of Port goals that are beyond our direct authority. This memo updates the Port's international policy priorities to guide and inform our engagement for 2026.

DETAIL

Driven by the Century Agenda, the Port is working to achieve ambitious goals that maintain Puget Sound as a premier international gateway for commerce and tourism that benefits the region while ensuring equity, sustainability, and quality of life for our region's residents. The Port of Seattle also strives to be a welcoming environment for our communities, visitors, and businesses. While the Port can modernize our facilities, set policies, and make investments in line with our values, we have limited control over the commercial aircraft and maritime vessels that utilize our gateway. Given that many of the ships and aircraft calling on our port have international itineraries, or are owned by companies with global reach, we need international standards and cooperation to fully achieve the Port's goals.

In 2025 the United States federal government's foreign policy and international priorities disrupted and challenged established norms, contributing to global instability in trade and diplomatic relations. The Port of Seattle continued its direct international engagement and experienced the critical role of subnational diplomacy in global venues where the United States federal presence has retreated.

In 2026, we anticipate the United States federal government to increasingly turn away from global collaboration and support in favor of increasing isolationism and assertive tactics. At the same time, this will be a significant year of international attention on Seattle as a host of the world's largest sporting event, the FIFA Men's World Cup. This is an opportunity for the Port and greater Seattle community to positively grow our international profile as a welcoming, modern city. Similar to 2025, the Port will continue our direct engagement with port partners and participation in global forums to make progress on our goals.

Success of these international priorities will be achieved through highlighting the Port's continued local investments as well as through engagement, collaboration, and alignment on issues with international ports and representatives, subnational governments, industry associations, private industry, non-governmental organizations, and where possible, the United States government.

Following Commission feedback on these draft policy priorities, staff will revise and bring final proposed international priorities for full Commission approval.

2026 INTERNATIONAL POLICY PRIORITIES

Promote Transparency, Collaboration, and Consistency

Encourage transparency and broad engagement in developing globally consistent standards and policies for aviation and maritime industries to promote public awareness, industry alignment, and certainty for planning and effective implementation. Coordinate with The Northwest Seaport Alliance on international maritime engagement.

Promote collaboration, share best practices and challenges, and foster relationships to develop comprehensive solutions to complex global issues and help achieve our goals by engaging in key international forums such as the International Civilian Aviation Organization (ICAO), International Maritime Organization (IMO), United Nations Climate Conference of Parties; with international partners including our sister ports, particularly, Busan, Kobe, Rotterdam, and Singapore; and industry associations and non-government organizations including Airports Council International, International Association of Ports and Harbours (IAPH), and Getting to Zero Coalition.

Promote Equity, Environmental Justice, and Sustainable Development

Promote and support the adoption of principles and values by international organizations that commit them to equity, environmental justice, and sustainable development, as well as engaging communities most impacted by industries associated

with port operations. Actively seek opportunities to partner with other organizations in achieving equity and environmental justice goals.

Advocate for policies, programs, projects, and investments that support and welcome immigrants and refugees, encouraging organizations to adopt policies that create inclusive ports of entry, advance language access, promote international travel, and ensure safe and healthy communities, like the recently updated Welcoming Port Policy.

Advocate for policies, programs, projects, and investments that advance equity, support environmental and economic justice, and implement the United Nations' Sustainable Development Goals and United Nations Development Program's Environmental Justice Technical Report. Solutions must be co-developed with and center the experiences and voices of the communities most impacted.

Actively pursue international collaborations and partnerships to advance our workforce development programs. Encourage international organizations to develop and strengthen workforce development programs in the maritime, aviation, construction, and green jobs industries, sharing resources, information, and best practices.

Monitor international actions and projects implemented to achieve net-positive biodiversity outcomes and inform the Port of Seattle's actions that restore, maintain, and enhance biodiversity.

Respecting the Rights of Indigenous Peoples

Support the United Nations' Declaration on the Rights of Indigenous Peoples and the ways it works to uphold and defend Tribal Sovereignty.

Addressing Climate Change and Reducing Air Emissions

Support robust and immediate climate action, policies, and initiatives, like the Paris Agreement and Clydebank Declaration, that demonstrate ambitious, feasible, and equitable approaches to mitigate climate changing factors and prepare for climate impacts, even if the United States is no longer a party to such agreements.

Encourage international organizations to incorporate environmental justice principles into their climate policy that are people-centered, developed with impacted communities, and seeks mitigation as well as better quality of life for communities who are experiencing the burden of climate change.

Support data-informed decision-making based on scientific information (quantitative and qualitative) and lived experiences; progress reporting; and information sharing on global climate impacts and mitigation and adaptation strategies relevant to the Port, King County, or the Pacific Northwest.

Monitor international developments of standards for safe handling and storage of emerging alternative aviation and maritime fuels, such as hydrogen and methanol, as well as new technologies at the ICAO and IMO. Provide input on issues that could impact worker and community safety and airport and seaport operations.

Support ICAO implementation of policy instruments, including the Carbon Offsetting and Reduction Scheme (CORSIA), to achieve net zero aviation emissions by 2050 and encourage research and investments that accelerate the uptake and supply of Sustainable Aviation Fuel.

- (1) Monitor developments related to emissions and other aviation environmental impacts within the ICAO Committee on Aviation Environmental Protection (CAEP) that assists the ICAO Council in formulating new policies and adopting new Standards and Recommended Practices (SARPs) related to emissions, and more generally to aviation environmental impact.

Monitor international policies and incentives for producing, distributing, and building infrastructure for sustainable aviation and maritime fuels.

Support the IMO's adoption of policies to reduce climate and air pollution emissions from commercial shipping by 2050 including:

- (1) Global maritime fuel standard that reduces the intensity of greenhouse gas emissions in fuel over time and meets sustainability criteria.
- (2) Economic measures that create a level playing field globally and incentivize the supply and use of low and zero emission maritime fuels.
- (3) Ports as an eligible entity to receive future emissions revenue.
- (4) Just Transition policy that works to equitably distribute gains and reduces the risk to developing countries in the transition to low and zero emission fuels.

Encourage knowledge sharing, especially between Green Shipping Corridors and their international partners, to accelerate supply and uptake of low and zero greenhouse gas emission fuels and maximize participation by ports and ships. Engage the U.S federal government and other international governing bodies in these conversations.

Contribute to efforts coordinated by IAPH to standardize shore power connections and power distribution differences to increase interoperability between ports and ships and increase connection rates.

Monitor development of international standards for offshore wind and other alternative energy developments; and encourage collaboration in standards between governments and leading international developers to reduce barriers to deployment. Support the development of offshore wind and alternative energy supply chains that prioritize low greenhouse gas emissions, economic development, and social equity.

Reducing Aviation and Maritime Noise

Monitor and support developments to reduce noise from commercial aircraft by the ICAO Committee on Aviation Environmental Protection (CAEP), including through aircraft technology and airport operational best practices.

Support the IMO's voluntary guidelines to reduce underwater noise from ships and share experiences and outcomes from the Port of Seattle's efforts to help inform uptake and use of the guidelines.

Improving Water Quality/Marine Health

Monitor the IMO's development of standards for the discharge of wash water from exhaust gas cleaning systems and the use of risk and impact assessments to inform decisions about restrictions or limits to wash water discharge.

Encourage awareness of, and actions to reduce, ocean acidification impacts to global marine ecosystems, communities, and associated industries. Share Port research on local, nature-based carbon remediation including kelp and eelgrass enhancement, with international partners through the International Alliance to Combat Ocean Acidification.

Combat and Reduce Human Trafficking

Monitor and encourage efforts at ICAO, the IMO, and other international organizations we engage with to increase awareness of and combat human trafficking in aviation and maritime industries and share the Port's experience with supporting the national awareness campaign. Highlight the Port's public-private partnership with local organizations to combat human trafficking. Seek opportunities to partner and expand this work in preparation for hosting the 2026 World Cup, including sharing resources, such as the Anti-Human Trafficking Toolkit for host cities that the Port will finalize in Q1 2026.

Support Sustainable Tourism

Support the Global Sustainable Tourism Council and similar organization's best practices that balance the environmental, social, cultural, and economic aspects of tourism and share the Port's, and our Washington State tourism partners', sustainable and inclusive tourism best practices.



Amount of this request: \$3,300,000

Total estimated project cost: \$101,300,000

ACTION REQUESTED

Request Commission authorization for the Executive Director to approve additional funding in the amount of \$3,300,000 for completion of the Terminal 91 Berths 6 & 8 Redevelopment project, to resolve all outstanding contractor claims, and advance the completion of the two berths to allow for fishing fleet use starting in March 2026.

EXECUTIVE SUMMARY

Construction of the Terminal 91 Berths 6&8 project is now nearing completion (approximately 85% complete, with all pile driving and wharf structural work complete), and while the project expenditures and commitments remain within the currently authorized budget, additional funds are required to close out the project. The anticipated construction completion of the contract work is currently July 2026, and completion of the berth under the current extended contract schedule would not allow for the use of the berths for this fishing season in 2026.

Terminal 91 is one of the Port's oldest facilities with many layers of previous development. The project work encountered several obstructions and construction complications, including subsurface features and foundations not identified in the design, a failing sheet pile wall requiring significant redesign of both the new sheet pile alignment and further associated pier design changes. These required changes to the design, along with other field complications, have resulted in an overall extension of the construction duration, and resulting claims from the prime contractor, Pacific Pile and Marine, for time impacts and other associated issues.

The Port's Construction Management group has negotiated a proposed resolution of all current and future claims by the contractor through the completion of the work that would fund the acceleration of the work to complete the berths and make them available for use by March of

2026. This would allow the North Pacific fishing fleet to occupy these berths up to 4 months earlier than currently anticipated.

This change will bring the construction contingency utilized up to 13%. While prior project funding requests included a 10% construction contingency, 15% would have been more appropriate for a more complex project on industrial sites such as Terminal 91.

Approval of this funding request will allow completion of the project with the earliest possible use of the berth space while limiting uncertainty regarding resolution of current and future construction claims.

JUSTIFICATION

The redevelopment of Berths 6 & 8 supports the following Maritime Division goals toward achieving Century Agenda objectives:

1. Continue to grow the economic value of the fishing and maritime cluster including the number of local jobs and regional business revenue.
2. Prioritize uses that support the commercial fishing industry, with a focus on anchoring the North Pacific fishing fleet in Seattle.
3. Supports the Port’s strategy to “be the greenest and most energy-efficient port in North America” by installing solar array infrastructure, stormwater treatment infrastructure, direct connection for vessel sanitary sewer, and replacing existing creosote piling with cement and recycled steel materials.

Diversity in Contracting

The project team coordinated with the Diversity in Contracting Department to determine appropriate Women and Minority Business Enterprise aspirational goals for this project and identified a 5% WMBE contracting and 15% apprenticeship goals for the major works contract. These goals are currently being met.

DETAILS

Berths 6 & 8 were the last remaining original timber pier berths at Terminal 91 and are at the end of their service life. Approximately 30% of the apron was condemned, and the remaining sections posted with severe load limits. Originally built in the 1910s, this section of Pier 90 was most recently rehabilitated in 1985, and little had been done to the structure since then. Redevelopment of Berths 6 & 8 is critical to ensuring the long-term viability of the port as the home to the North Pacific fishing fleet.

The redevelopment includes demolition of approximately 62,250 square feet of condemned existing timber apron and replacement of approximately 780 linear feet of seawall (northerly portion of Berth 6 and entire Berth 8), removal and relocation of existing gangway, floats and boathouse, removal/replacement of existing small office structures, and reconstruction of a concrete apron structure at 600 pounds per square foot load capacity along the current alignment. The project includes the removal of over 2,200 failing creosote piles, installation of approximately 320 concrete and steel piles, with an overall decrease in overwater coverage. The project work also includes stormwater improvements, upgraded shore power connections, renewable energy through new solar panel arrays, and a direct connection for vessel sanitary sewer.

Scope of Work

This project provides significant waterside and landside improvements, including the following:

- Dock demolition and replacement, relocation of boat house and removal of existing small boat floats. Demolition of the existing pier deck and structure, including removal or cutoff of approximately 2,200 existing creosote piles. Removal and regrading of the existing under pier slope and replacement of the upland sheet pile wall.
- Placement of approximately 240 prestressed concrete structural piles and approximately 80 steel fender and guide piles, placement of 4 feet of riprap rock and habitat fish mix, placement of the new concrete precast deck panels, bullrail, utilities, bollards, upgraded shore power connection points and appurtenances.
- Removal of the existing buildings A-310 building (currently leased by American Seafoods), A-300, A-400, A-301, A-500, A-501 (occupied by Port Operations and police), removal of existing pavement and installation of deep soil mixing soil amendments, stormwater treatment system, and surface regrading.
- Replacement of the six existing buildings with two new modular buildings for tenant and Port use, paving and striping, installation of electric vehicle charging infrastructure, and installation of modernized electrical substation to service the buildings and vessels at the pier.

Schedule

Currently the construction is approximately 85% complete and anticipated to reach Substantial Completion in July of 2026 based on the latest contractor schedule. Acceptance of the negotiated agreement with Pacific Pile and Marine would allow both berths to begin operations approximately 4 months earlier in March 2026.

Construction currently 85% complete




Construction changes / site conditions





ACTION REQUESTED

Commission determination that a competitive process is not appropriate or cost effective consistent with Revised Code of Washington 53.19.020(5) and authorizing the Executive Director to execute a contract with the Workforce Development Council of Seattle-King County, a non-profit agency, to advance maritime workforce recruitment and case management. The contract duration potentially extends through 2028 at the rate of up to \$200,000 annually, totaling a budget of \$600,000.

EXECUTIVE SUMMARY

The Port Commission authorized \$2.17M in funding for maritime workforce investments in the Sept. 9, 2025 meeting. The Economic Development Division (EDD) has identified an opportunity to partner with the Workforce Development Council of Seattle-King County (WDC) to reduce the need for Port maritime recruitment funds and increase access for jobseekers to other critical services provided via the WDC and WorkSource system.

The WDC is uniquely positioned to partner with the Port as the sole organization in King County that receives both Washington state Economic Security for All funds and federal Workforce Innovation and Opportunity Act funds. When combined with Port funds and directed toward maritime workforce recruitment and case management, these federal and state resources can leverage the Port's expenditures on workforce development for maximum impact.

BACKGROUND

Port Commission approved Phase 1 of the maritime workforce development strategy and budget on Sept. 9, 2025. Port workforce development staff are in process of procuring partners for:

1. jobseeker recruitment and case management,
2. maritime training and
3. job placement services.

All three scopes are necessary to increase the pool of qualified maritime workers and effectively connect them to maritime employers.

During the procurement planning phase, EDD identified an opportunity to leverage state and federal funding designated for workforce development councils across the state, including the WDC of Seattle-King County. These funds support jobseekers to explore career options, address barriers to employment and offer financial incentives while jobseekers are in training and looking for work. The WDC currently receives these federal and state funds and distributes them to a number of community-based organizations, including but not limited to ACRS, Neighborhood House, YWCA and TRAC Associates.

If approval is granted, EDD will contract with the WDC to outline how Port funds will augment state and federal dollars for recruitment, case management and financial incentives. The portion of Port funding required for the contract will be dependent on contract negotiations and available state and federal funding.

JUSTIFICATION

EED staff propose a competitive exemption contract with the WDC, a 501(c)(3) nonprofit organization that serves as the local workforce development board under the federal Workforce Innovation and Opportunity Act (WIOA). The WDC operates as a regional workforce development backbone organization by convening stakeholders, shaping policy, and investing in solutions that reflect community needs and priorities.

The WDC is uniquely positioned to partner with the Port of Seattle as the only organization in King County that receives both federal Title I [Workforce Innovation and Opportunity Act](#) (WIOA) formula funds and Washington State [Economic Security for All](#) (EcSA) funds. No other entity in the region holds this combined statutory authority, geographic jurisdiction, and fiduciary responsibility. The WDC serves as the federally designated Local Workforce Development Board for the Seattle–King County region under WIOA and is governed by a cross-sector board of directors appointed by the Chief Local Elected Officials—the King County Executive and the Mayor of Seattle. In this role, the WDC administers and oversees WIOA formula funding and EcSA investments on behalf of the region. Under WIOA, only a designated Local Workforce Development Board may administer formula workforce funds within a given local area.

Because of the WDC's unique role, a competitive process is not appropriate or cost effective, and a competitive exemption is appropriate in accordance with RCW 53.19.020(5). The WDC service providers are part of the WorkSource network which also creates efficiencies in service delivery through the WDC's established network of community-based providers and WorkSource partners. Services will be begin sooner and avoid a time-consuming competitive procurement process that would waste the time of community organization who may apply but be disadvantaged by not having similar funds to leverage.

ALTERNATIVES AND IMPLICATIONS CONSIDERED

Alternative 1) Do not authorize agreement with WDC and require competitive solicitation for recruitment and case management services.

Pros:

- Provides an opportunity for more organizations to apply.
- Puts the Port in a more direct management role of the recruitment and case management services.

Cons:

- Spend more Port tax levy resources on services that could be provided using state and federal dollars.
- Services would start later due to the time it takes to solicit recruitment and case management services.
- Funded organizations may not be connected to other critical services offered through WorkSource.

Alternative 2 – Authorize a \$600,000 three-year competitive exception contract with the Workforce Development Council to implement maritime recruitment and case management at a cost not- to- exceed \$600,000.

Pros:

- Takes advantage of available federal and state workforce development dollars and reduces the Port's 2026 - 2028 expenses.
- Creates efficiencies in service delivery through the WDC's established network of community-based providers and WorkSource partners.

Cons:

- Limits the ability of other organizations to apply.
- Reduces the Port's direct influence over the organizations conducting the recruitment since they will have a contract with the WDC and not the Port.

This is the recommended alternative.

Request Commission authorization for Executive Director to execute an Interlocal Agreement (ILA), pursuant to chapter 39.34 RCW, with Washington State Department of Transportation (WSDOT), Central Puget Sound Regional Transit Authority, City of Seattle, and King County to implement the Capacity Building Mentorship Program for the purpose of strengthening the capacity of small businesses in construction and consulting projects.

Signing the agreement would allow WSDOT to administer funds to the program administrator and submit invoices to the Port and other parties for reimbursement. The Agreement's performance period commences on January 1, 2026, and is to be completed on December 30, 2027. The agreement will be for two years for a total cost of \$40,000 to the Port, which is 11% of the total contract amount of \$365,000.

EXECUTIVE SUMMARY

The Diversity in Contracting team at the Port has been in discussion with WSDOT and Sound Transit to join the relaunch of the Capacity Building Mentorship Program (CBMP), alongside the City of Seattle and King County who are also participating in the program relaunch.

The CBMP is a long-term effort to strengthen the capacity of small businesses in Washington by connecting them with larger firms engaged in government construction and consulting projects. It was originally launched in 2018 through a partnership between the Washington State Department of Transportation (WSDOT), the American Council of Engineering Companies (ACEC), and the Associated General Contractors of Washington (AGC). In 2019, the partnership grew to include Sound Transit. Since its launch, more than 130 proteges have participated in

one of the program's seven cohorts, with over 88% of mentors and protégés in the most recent cohorts reporting being satisfied or very satisfied with the program.

JUSTIFICATION

Joining the Capacity Building Mentorship Program is an invaluable way for the Port to leverage and contribute to the collaborative efforts of our peer agencies to accomplish our shared goals of strengthening the capacity of the region's small businesses. It is a direct way to advance the Port's Century Agenda Goal of responsibly investing in the economic growth of the region and all its communities, as well as increasing the utilization of WMBE and DBE firms and eliminating disparity of access to opportunities.

DETAILS

The Diversity in Contracting team at the Port has been in discussion with WSDOT and Sound Transit to join the relaunch of the program, alongside the City of Seattle and King County who are also participating in the program relaunch. All five government agencies share similar goals to increase small business capacity and ability to gain work, and seek to advance those goals by establishing specific protocols for developing, implementing, delivering, and expanding the Program.

The purpose of the Agreement between the five agencies is for WSDOT to act as a pass-through agency for CBMP administration funds, and to define the terms and conditions for work performed to support CBMP implementation.

Scope of Work

A competitively-selected consultant shall manage the CBMP Program in coordination with WSDOT, with input from program partners, and include the following elements:

- The Consultant will be the primary point of contact for all past and current Mentor and Protégé participants.
- The Consultant will fund and update the CBMP Website.
- The Consultant will develop and maintain an outreach strategy.
- The Consultant will assess potential program candidates.
- The Consultant will identify subcontractor and sub-consultant qualification levels and Tier levels before connecting them with the appropriate Mentor firm.
- The Consultant will coordinate virtual or in-person matchmaking engagements between yet-to-be-paired Mentors and Protégés.
- The Consultant will work with all Mentors and Protégés to develop program-approved Individual Development Plans and Memorandums of Understanding (MOU).

- The Consultant will organize and lead program orientations, meet and greet sessions, and networking events for the participants.
- The Consultant will conduct regular program benchmark reviews and provide updates at bi-weekly meetings with CBMP representatives.
- The Consultant, with input from CBMP representatives, shall provide a report based on quarterly surveys or firm questionnaire findings.
- The Consultant, with support from CBMP representatives, shall reach out to program participants to address concerns.

Period of Performance

Subject to its other provisions, the Agreement's performance period shall commence on January 1, 2026, regardless of date of execution, and be completed on December 30, 2027, unless terminated sooner as provided in the Agreement or extended through a properly executed amendment.

ADDITIONAL BACKGROUND

The Capacity Building Mentorship Program (CBMP) is a long-term effort by the Washington State Department of Transportation (WSDOT) to strengthen the capacity of small businesses in Washington by connecting them with larger firms engaged in government construction and consulting projects. Since its inauguration, the Program has promoted building relationships and expanding contracting opportunities as the most effective way to strengthen the capacity of Small Businesses. Since its launch in 2018, more than 130 protégés have participated in this program in one of seven cohorts, with over 88% of mentors and proteges in the most recent cohorts reporting being satisfied or very satisfied with the program.

The Program was originally launched in March 2018 through a partnership between WSDOT, the American Council of Engineering Companies (ACEC), and the Associated General Contractors of Washington (AGC), with Thor Construction serving as program manager. In April 2019, it was relaunched as the Capacity Building Mentorship Program in partnership with Sound Transit, ACEC, AGC, and the Washington Minority Business Development Agency (MBDA) Business Center.

On June 30, 2025, the WA MBDA Business Center closed. To ensure continuity, WSDOT hired CORE Strategists to manage the program during this period. WSDOT has selected a long-term CBMP program administrator, Apex Accelerators, that began work in January 2026.

Differentiation from Port Business Accelerator Program

Diversity in Contracting has organized its own mentorship program, the Port of Seattle Small Business Accelerator Mentorship Program, since 2021. This program occurs annually in the Fall wherein 11-15 select businesses in Port-related industries, are each paired with an industry mentor and experience a robust curriculum, primarily in-person, over the course of three months. The Program is known for the unique visibility and access it grants these businesses to the Port, by connecting them to key Port decision makers, and educating them on the Port's unique contracting opportunities and needs. It is also singular in its ability to establish meaningful relationships, and a sense of community among the cohort businesses and their

mentors – allowing for frequent co-learning and resource-sharing within and across industries and which lasts well past the end of the program.

The Capacity Building Mentorship Program, with its approach to government contracting across multiple agencies, longer program duration, as well as its intent focus on the individual mentor-protege relationships, will be an excellent complement to the existing Port Business Accelerator Program.

ACTION REQUESTED

Request Commission authorization for the Executive Director to advertise and execute a construction contract for the Flight Corridor Management Project - 2024. The total cost estimate for this request is \$6,000,000.

EXECUTIVE SUMMARY

The 2024 Flight Corridor Management Project (2024 FCMP) is intended to remove existing and anticipated obstructions consisting primarily of trees around Seattle-Tacoma International Airport (Airport); replant trees of compatible species, in appropriate locations; and establish access agreements with agencies to perform obstruction management and prevent establishment of future obstructions.

SEA operates under several federal and state regulations and requirements to ensure safe operating conditions which include the removal of obstructions. Rigorous environmental management practices will be implemented to minimize environmental impacts including following the Port's tree replacement standards; and comply with applicable tree replacement standards in surrounding jurisdictions for obstructions located outside the Airport Activity Area (AAA). Replanting and revegetation will occur on-site where trees are removed or at nearby off-site properties. Staff will work with the local jurisdictions on any site-specific mitigations. For this five-year project, 197 trees were identified as obstructions. Of those, 158 are on Port property, 39 on public agency properties and none on private property.

To support effective communication and transparency with communities affected by the 2024 FCMP, a comprehensive outreach and communication plan for those areas has been implemented and communications will continue throughout the obstruction removal periods. This project will also look to maintain mitigation sites and replace trees that did not survive from prior replanting efforts.

JUSTIFICATION

SEA operates under several federal and state regulations and requirements to ensure safe operating conditions which include the removal of obstructions. These regulations and requirements include:

1. Federal Requirements for Airport Operators to Control Obstructions

- Federal Aviation Regulation (FAR) Part 77, “Safe, Efficient Use, and Preservation of the Navigable Airspace”.
- FAR Part 139, “Certification of Airports”.
- Advisory Circular (AC) AC 150/5300.13B, “Airport Design”.
- Grant Assurance 20, “Hazard Removal and Mitigation”.
- Grant Assurance 21, “Compatible Land Use”.

2. State Requirements for Airport Operators to Control Obstructions

- RCW 14.12.020, “Airport hazards contrary to public interest”.
- RCW 14.08.030, “Acquisition of property and easements—Eminent domain—Encroachments prohibited”.

Diversity in Contracting

Through the Diversity in Contracting program, a Women and Minority-Owned Business Enterprise (WMBE) aspirational goal has been established for this program at 10% and will be included in future contracts.

DETAILS

The Flight Corridor Management Program is an ongoing regulatory safety program that, approximately every five years, evaluates and mitigates obstructions in the vicinity of the airport.

Scope of Work

Scope of work for this authorization includes:

- (1) Obstruction Removal.
- (2) Site Treatment.
- (3) Obstruction Replacement.
- (4) Site specific mitigations in conjunction with the local jurisdictions.
- (5) Monitoring & Maintenance.
- (6) Outreach and Communications.

ALTERNATIVES AND IMPLICATIONS CONSIDERED**Alternative 1** – Do not authorize funds for construction.Cost Implications: \$0.Pros:

Annual Budget Status and Source of Funds

The expenditures will be included in the division's annual operating budget. The 2026 operating budget included \$2,001,500. The cost for removal and replacement on Port property is an operating expense and the expenditure on non-Port property is categorized as non-operating Public Expense. The project costs will be accounted for as public expense and included in the airline rate base (Airfield Movement Area) as an amortized cost, recognizing there is a multi-year benefit. The funding source will be the Airport Development Fund (ADF).

Future Revenues and Expenses (Total cost of ownership)

Newly planted trees will need to be monitored and maintained for the first 5 years. The first year is included in the construction contract. Years 2-5 will need monitoring and oversight; potentially a minor amount of consultant support will be required along with Aviation Maintenance staffing services for tree maintenance.

ADDITIONAL BACKGROUND

As part of previous efforts, the Port completed an aerial obstruction analysis for the 2019 FCMP to identify the number of obstructions. In response to community feedback, Commission guidance and consultation with the FAA, the Port used revised criteria in 2018 to identify obstructions that had the most direct impact to safe and efficient aircraft operations. Once all obstructions were verified by site visits, the removal and replacement work began in 2020. All removal and replanting work were completed in 2022. Tree replacement sites on Port property were also completed and were subject to a 5-year performance monitoring and maintenance period for tree survival and invasive species cover.

Meeting Date: February 10, 2026

In total, 978 trees were removed in the previous projects. The majority were on Port property (789) with the remaining on Washington Department of Transportation (WSDOT) right-of-way (102), other public properties (47) and private properties (40). On Port property, the Port replanted at a 4:1 ratio, including clearing invasive vegetation to prepare sites for planting. For other public properties, the Port paid each entity in-lieu fees for replanting at the ratio specified by city code. For private properties, the Port offered to replace trees either on-site or on Port property up to a four to one ratio.

The Port coordinated directly with all public and private property owners on scopes of work specific to their properties and on permanent easements on the properties where there is potential that additional trees may require removal in the future. The easement values were determined by an appraiser in accordance with applicable standards for determining fair market value.

Environmental best management practices are an integral part of the Flight Corridor Management Program's overall design, leaving vegetation barriers near buildings and streets, planting low growing native varietals that will not become future obstructions, and removing and controlling invasive species.

AN ORDER OF THE PORT OF SEATTLE COMMISSION

...to increase Transparency and Reporting standards and requirements for the Port of Seattle Police Department.

PROPOSED

February 10, 2026

INTRODUCTION

The Port of Seattle Commission has a duty to ensure Port of Seattle Police Department (POSPD) practices align with public trust, transparency, and Washington state law. This Order builds on the POSPD mission and practices and seeks to advance the Department's transparency, accountability, and alignment with the Port of Seattle's values and legal obligations.

The current Federal Administration's mass deportation campaign has created an incredible amount of fear, concern and mistrust in our community. Emphasizing clear visual identification, regular training on de-escalation tactics, and transparent reporting practices are essential to maintaining public confidence in policing at Port-owned facilities, including Seattle-Tacoma International Airport. As residents and visitors travel through our airport and seaport facilities, we want to ensure that the POSPD have clearly identifiable uniforms, so as to minimize confusion and panic. High-visibility police activities like training and operations in public-facing, pre-security areas of Port facilities may cause alarm in this current environment for members of the general public, including travelers, workers, and groups permitted to exercise free speech. This Order requires notification to Airport Duty Managers during pre-planned operations by POSPD that could reasonably cause confusion for the travelling public.

The breakdown of regular investigative order in the face of recent deaths of U.S. citizens Renee Good and Alex Petti in Minneapolis and the excessive use of force by the federal law enforcement compels all police forces across the country to ensure that any investigations into use of force by its members meet the highest possible standards of transparency and accountability. This Order outlines a transparent presentation of use of force and other statistics in the POSPD's annual report.

TEXT OF THE ORDER

37 The Port Commission hereby directs the Executive Director to implement the following:

38 **Division Naming and Uniform Conventions**

- 39 1. The POSPD shall make reasonable efforts to adhere to naming conventions for its various
40 divisions that clearly distinguish Port police divisions and departments from all federal law
41 enforcement agencies and activities.
- 42 2. Effective immediately, eliminate the use of “Homeland Security Division” as a name for a
43 Port Police division.
- 45 3. The POSPD, and all divisions therein, shall consider additions or changes to the standard
46 POSPD uniform that highlight for the public the connection with Port of Seattle and can
47 easily be identified as part of Port of Seattle branding, except in cases where plain clothes
48 or other security measures require non-standard uniforms.

50
51 **Notification**

- 52 1. The POSPD conducts pre-planned emphasis and training operations on airport premises on
53 a regular basis in high passenger volume areas clearly visible to members of the general
54 public. Per current standards, POSPD alerts the Airport Duty Manager (ADM) when such
55 patrols occur at SEA. For the purpose of clear public communication, the ADM shall notify
56 the airport PIO in advance of pre-planned emphasis and training operations, as necessary.
- 57 2. The POSPD shall coordinate with External Relations to highlight the role of the POSPD
58 for the travelling public including, for example, announcements, signage and video, to
59 include a focus on the role as part of the Port of Seattle team.

61
62 **Annual Reporting and Transparency Requirements**

- 63 1. The Annual Report submitted by the POSPD to the Commission shall include the following
64 information on use of force: all categories of use of force as report to Washington State
65 Data Exchange for Public Safety (WADEPS); including demographic information of
66 subjects against whom force was used when collected.

- 70 2. The Annual Report should also include a summary of commendations and a summary of
71 complaints reviewed by POSPD internal affairs including where the complaint originated;
72 how complaints were categorized; whether complaints were sustained or closed with
73 another disposition; and disciplinary actions taken where applicable.

- 75 3. Both the Annual Report and the use of force report addendum shall be submitted to the
76 Port of Seattle Commission no later than July 30th of each year.

78 **STATEMENT IN SUPPORT OF THE ORDER**

79 The POSPD is accredited by the Commission on Accreditation for Law Enforcement Agencies
80 (CALEA) and operates with the highest standards of transparency, accountability, and public trust.
81 The Port of Seattle Commission has a responsibility to communicate clear expectations for
82 policing practices that reflect the values of the Port and the communities it serves.

83

84 In the current political environment, concerns about the presence and conduct of federal law
85 enforcement – particularly related to immigration enforcement – have the potential to cause deep
86 concern and fear in our communities. To that end, it is essential that the Port further enhance its
87 transparency and accountability, to ensure travelers, employees and visitors that our facilities are
88 safe, secure, and welcoming.

89

90 This Order addresses several areas where enhanced clarity and accountability will strengthen
91 public confidence in Port policing operations. Ensuring that Port of Seattle Police are clearly
92 identifiable in contrast to Federal security apparatus and the addition of Port of Seattle branding
93 ensures clear visual identification. These changes help ensure that Port police officers are readily
94 identifiable to the public.

95

96 The reporting requirement for pre-planned training operations in high-visibility, public-facing
97 areas recognizes that police presence in these spaces can have significant impacts on travelers,
98 workers, and community members, if misunderstood, while meeting best practices for safety and
99 security. Notification to the Airport Duty Manager and the Airport PIO, strives to create
100 appropriate coordination while preserving the Chief of Police's operational authority.

101

102 Finally, the annual reporting requirements will provide the Commission and the public with
103 regular, comprehensive information about use of force incidents and complaint handling.
104 Transparency in these areas is fundamental to accountability and allows for ongoing assessment
105 of policing practices.

107 Through this Order, the Commission seeks to acknowledge existing best practices and advance its
108 commitment to supporting policing that is transparent, accountable, and aligned with the Port of
109 Seattle's values of equity, inclusion, and public service.

EXECUTIVE SUMMARY

The proposed amendments update the committee's charter scope and responsibilities, including oversight of initiatives formerly managed by the Airport Workforce Conditions Ad Hoc Committee. These initiatives—Healthcare for SEA workers; Labor Access and Badging; and a Childcare Feasibility and Navigator Program are in progress, as are other initiatives such as ORCA Card passes and will now be managed by this committee. The proposed changes also include a committee name update to reflect the expanded scope of work for the Equity and Workforce Development Committee, ensuring continued focus on these priorities while formalizing the committee's role in advancing equity and fair workforce practices. If adopted, the new name of the committee will be the 'Equity, Workforce Development, and Conditions Committee.'

JUSTIFICATION

It is recommended to sunset the Airport Workforce Conditions Ad Hoc Committee and expand the scope of the Equity and Workforce Development Committee to formalize the previous work of the ad hoc committee into a standing committee format moving forward.

A RESOLUTION of the Port of Seattle Commission sunsetting the Ad Hoc Airport Workforce Conditions Committee and amending the Charter of the Equity and Workforce Development Committee, previously adopted by Resolution No. 3770, to update the name of the committee to the ‘Equity, Workforce Development, and Conditions Committee,’ and to further update the scope of the committee.

WHEREAS, on February 25, 2020, the Port of Seattle Commission adopted Resolution No. 3770, establishing the standing committee charters of the Commission; and

WHEREAS, on September 12, 2023, the Port of Seattle Commission adopted Order No. 2023-13, establishing the Ad Hoc Airport Workforce Conditions Committee to create opportunity for oversight and engagement with staff on programmatic, policy advocacy, and operational efforts related to the topics of access to childcare and healthcare for workers at Seattle Tacoma International Airport (SEA), including both Port employees and workers employed by SEA vendors, tenants, and service providers; and

WHEREAS, the Ad Hoc Airport Workforce Conditions Committee is a committee of limited duration, scheduled to sunset upon satisfactorily completing the scope of Order No. 2023-13.; and

WHEREAS, on December 16, 2025, the Ad Hoc Airport Workforce Conditions Committee recommended the Port develop a health care policy that sets minimum health care standards for workers at SEA; and

WHEREAS, it is now recommended to officially end operation of the Ad Hoc Airport Workforce Conditions Committee and to amend the scope of the standing Equity and Workforce Development Committee Charter to include review of, and provision of recommendations for, the development and implementation of policies regarding workplace conditions and access to services that affect recruitment, retention, and worker stability at Port facilities to improve operations, safety and customer experience; and

WHEREAS, it is further recommended that the Equity and Workforce Development Committee Charter be amended to include Civil Rights and Community Safety as a part of the committee's scope of work; and

WHEREAS, it is further recommended that the name of the Equity and Workforce Development Committee be amended to reflect these changes in scope of work.

NOW, THEREFORE, BE IT RESOLVED, by the Port of Seattle Commission:

44 Section 1. Amendment of Committee Name. Resolution No. 3844, is hereby adopted to
45 change the name of the Commission's Equity, Workforce Development Committee to the 'Equity,
46 Workforce Development, and Conditions Committee,' as shown in attached Exhibit A to this

I. INTRODUCTION

The Equity, **[AND]** Workforce Development **[AND] Conditions** Committee, herein referred to as “the committee,” is a standing committee created by the Port of Seattle Commission. The committee will provide information, advice, and recommendations about the port’s equity, workforce development, **[AND]** career connected learning programs and policies, **[AND]** diversity in contracting goals, **and programs and initiatives related to workforce conditions.**

- B. The Port of Seattle is committed to joining regional and national efforts to achieve equity and justice for all and recognizes our essential role in building a socially just institution by dismantling the structural barriers that have prevented the full participation of our most marginalized communities, particularly communities of color. To achieve equitable outcomes for all we will lead with a racial equity lens, instituting policies and practices that address the systemic inequity of economic opportunities, working conditions, impacts on local communities, and participation in port affairs.
- C. This charter defines the mission, composition, scope, authority, responsibility, and meeting structure of this committee.

II. COMPOSITION

The committee will consist of two Port of Seattle commissioners appointed by the commission president, after consultation with the commission, at the beginning of each calendar year in which the committee is active.

124 3. Review and provide recommendations to the commission on the development and implementation
125 of policies regarding workplace conditions and access to services that affect recruitment, retention,
126 and worker stability at port facilities in order to improve safety, operations, customer service,

130 port workforce development programs that support equitable access to port-related jobs and

133 C. Career Connected Learning: Review and provide recommendations to the commission to guide the

135 that those participating in workforce development programs have access to real-world learning
136 experiences in port-related industries and that connect students to meaningful and well-paying
137 jobs at the Port of Seattle.

139 D. Diversity in Contracting: Monitor the implementation of the Diversity in Contracting policy directive.
140 Review and recommend to the commission policies that provide economic development
141 opportunities to women- and minority-owned business enterprises based on equity principles.

143 E. Civil rights and community safety: review and provide recommendations to the commission on
144 monitoring and identifying areas of improvement relating to public safety operations, including the
145 Port of Seattle's police department and fire department, with attention to civil rights, civil liberties,
146 community trust, and the equitable treatment of all individuals within port facilities and operations,
147 including workers, travelers, and community members regardless of national origin or immigration
148 status. This also includes work related to title vi, language access, and anti-human trafficking.

150 F. ~~(E)~~ Communicate the port's approved legislative agenda to the public as it relates to the scope of work
151 for the committee.

155 IV. **AUTHORITY**

156 In pursuit of its mission and scope, the committee is not legally authorized to act on behalf of the Port
157 of Seattle Commission, but is authorized to conduct the following activities:

158 A. Gather and evaluate information, consider matters within the committee's scope of
159 work, and provide information, advice, and recommendations to the Port of Seattle Commission.

160 B. Communicate the priorities of the Port of Seattle Commission.

161 C. Engage in outreach efforts with community leaders and stakeholders and activities to
162 gather and evaluate information to provide to the Port of Seattle Commission.

163 D. If the committee determines that to meet its responsibilities it needs the independent
164 services of an outside advisor or consultant with equity, workforce development, or career
165 connected learning expertise, it may propose the retention of such advisor or consultant to the
166 commission for approval.

173 **V. DURATION**

175 The Equity, **[AND]** Workforce Development **and Conditions** Committee is a standing committee with
176 broad purview over matters related to equity and will continue indefinitely until the commission
177 repeals its charter.

191 **liaison(s), as assigned by the Commission Office, will support the work of the committee.** The
192 role of the committee liaison(s) shall be to:
